ScARF Outputs	Society of Antiquaries use of ScARF material as outlined above

**Commencement & Term**

This Licence shall come into force immediately upon completion of the online form and shall continue indefinitely in full force and effect [The Term].

## Licence

1. The Contributor agrees that he/she has Title or Consents which allows the granting of this Licence;
2. The Contributor grants to the Society a perpetual, non-exclusive Licence to allow The Society to publish or otherwise distribute all parts of the submitted Contribution, and for any digital surrogates created from it, to be used by the Society for study and research and for the submitted contribution to be disseminated online and in hard copy publication.;
